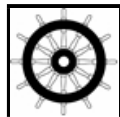

"Herculan Marine Navy Deck",

Three coat primary deck covering system with the following characteristics:

1st layer: Sigmaprime 200 (manufactured by Sigma Coatings), weight 75 g/m<sup>2</sup>, layer thickness 0.04 mm.

2nd layer: Herculan PSL IMO F, weight 1500 g/m<sup>2</sup>, layer thickness 1.00 mm.

3rd layer: Herculan PU 400 Safe IMO F, weight 400 g/m<sup>2</sup>, layer thickness 0.25 mm.

Total coating thickness: 1.29 mm

Area density: 1975 g/m<sup>2</sup>

## Application/Limitation

Primary deck covering, not generating excessive quantities of smoke nor toxic products in a fire.

Approved colour: grey and brighter colours

Maximum organic content (Sigmaprime 200): 26%

Maximum organic content (PSL IMO F): 62%

Maximum organic content (PU 400 Safe IMO F): 21%

Not to be used as an integrated part of horizontal class A division, unless tested as such.

The product may also be used as floor covering in accordance with IMO 2010 FTP Code part 5 appendix 4 paragraph 4.9.2.

Each product is to be supplied with its manual for installation and maintenance.
